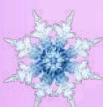

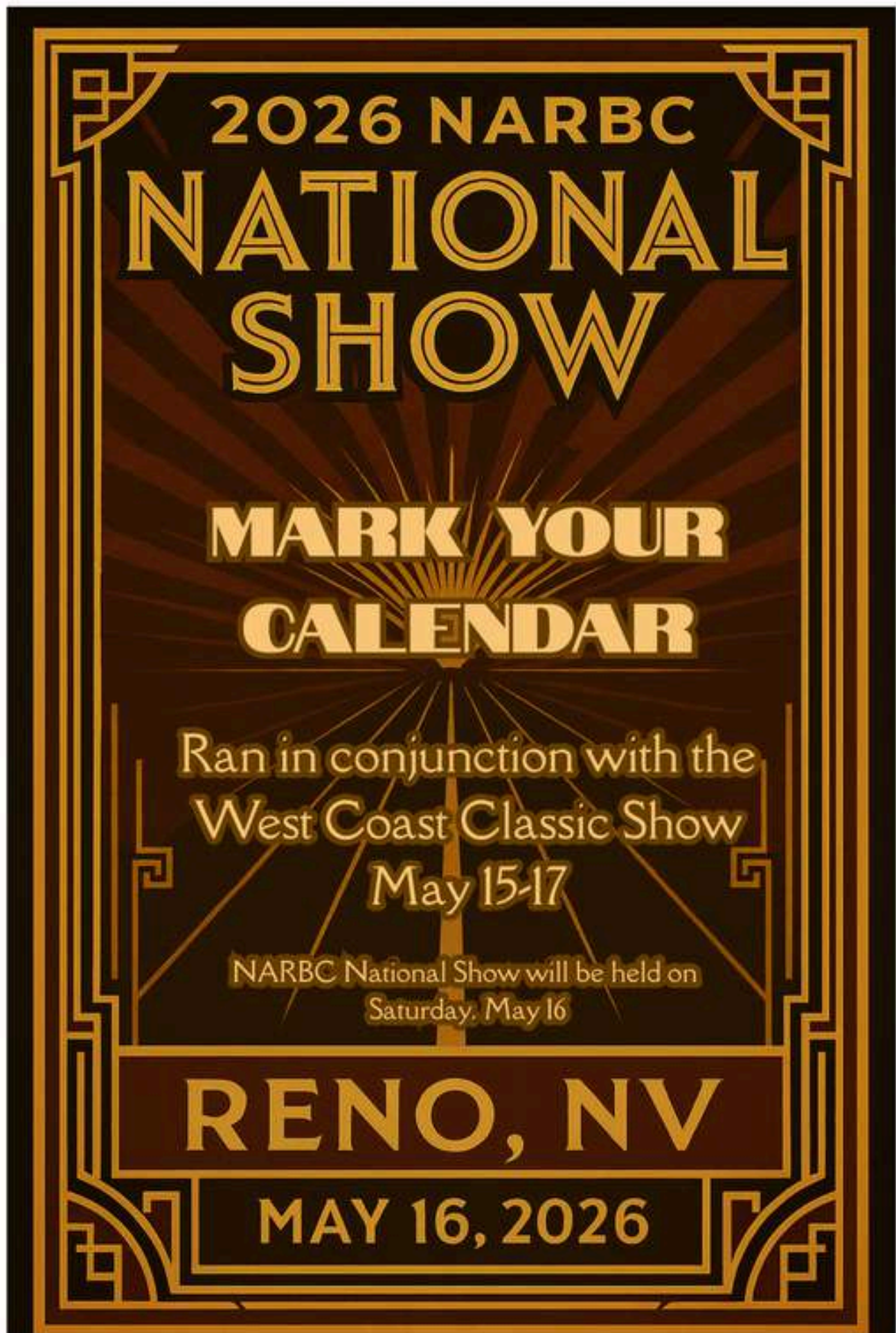

Board Meeting Minutes

NARBC Board Meeting July 22, 2025

The Board of Directors met on Tuesday, July 22, 2025, via a Microsoft Teams Meeting. President Jen Richardson called the meeting to order at 7:25 pm EST. Board members present were Lauren Cody, Jen Richardson, Andrea Evans, Casey Jones, June Abbott, Tammy Vaughn, Laurie Penterman, Jackie McDonald and Madison Wisecup.

Secretary Meeting Minutes- The Board members were provided with a copy of the meeting minutes from the June 16, 2025, board meeting. A MOTION was made by Andrea Evans to approve the meeting minutes. The motion was SECONDED by Casey Jones. Motion CARRIED.

Status of Membership- Laurie Penterman reported that we currently have 323 members in the club, 261 being Open members, and 62 Youth members. Since our June meeting, the club has gained two new Open members and one new Youth member. No Open members or Youth members renewed their membership since the last meeting. Laurie continues to send out renewal notices to expiring members via email.

Financial Report- June Abbott reported that the balance in the checking account is \$3,531.46, there is \$32,178.73 in the money market account, and we have a balance of \$338.16 in the PayPal account, for a total cash balance of \$36,048.35. There is \$3,004.14 in the held funds, so there are \$33,044.21 available funds.

Old Business

NARBC 2025 ARBA Convention Logo Contest- There was a total of 5 entries received. The board members voted for which two they liked best, and after the votes were tallied logo #4 was chosen to be the 2025 ARBA Convention Angora logo. A MOTION was made by Casey Jones to purchase the runner-up logo for \$150 so it can be used to be put on merchandise for members to purchase. It is an awesome logo; it just doesn't fit with the theme of this year's ARBA Convention. The motion was SECONDED by Andrea Evans. Motion CARRIED. This is not in the budget, but will be a bonus item.

2025 ARBA Convention

1. **Show Coop Donation Update-** Andrea spoke to Eric Stewart about the possibility of donated Angora show coops to be stored in the ARBA trailer. We're still waiting for the final blessing for ARBA to store them. How many coops do we want on each of the two judging tables? 15 coops were donated to the Rabbit Renegades Club for this year's National Angora Show. We'll figure out the cost when we know how many we want.
2. **Banquet Update-** We do not have a Banquet Chairperson. Andrea knows people who live in the Indianapolis area who can recommend restaurants. It is preferred that attendees order off the menu. June said that if Andrea finds a restaurant that she and Deb Clemens would manage the collecting money for the banquet tickets.
3. **Alicia Andrus is putting together the Angora Convention Mini Guide.**
4. **Judge Assignments-** Travis Finkle will judge the Open English and French Angoras. Steven Buell will judge the Open Giant and Satin Angoras and all of the Youth Angoras. If entry numbers are crazy, we can re-evaluate who should judge what.
5. **We are still in need of a Booth Chairperson.** June said she would man the booth during judging since she will not be showing any rabbits.

COD- Club Support in Non-Financial Ways

1. **Possible Section in The Angora News for updates and progress of current Angora CODs.** A MOTION was made by Casey Jones to have COD progress updates in The Angora News. The motion was SECONDED by Tammy Vaughn. Motion CARRIED.
2. **Opportunity to advertise fundraisers to support COD teams-** If there was a fund-raiser, could it be advertised in The Angora News and the NARBC Facebook page? So what if no other breed clubs do this. The entire club should have the chance to support the COD if they choose to. We'll discuss COD fund-raising at the next board meeting.

New Business

Sweepstakes Awards- The current Policies and Procedures Manual states that *National Sweepstakes will run from August 1 through July 31, with the awards given at or before the ARBA Convention for the top 10 in each breed and the top 3 in wool classes of each breed. It also does not state how many ROY awards.*

A proposal has been made to change the verbiage in the PPM to say National Sweepstakes will run from August 1 through July 31, with awards given at or before the ARBA Convention to the top 10 in each breed and the top 3 in wool classes of each breed. To be eligible to qualify for an award, exhibitors must earn a minimum of 100 points during the sweepstakes year. In addition, Rabbit of the Year awards will be presented to the top 5 rabbits based on total ROY points earned during the same period.

This will let everyone know exactly which placings receive awards. A MOTION was made by Jackie McDonald to accept the new sweepstakes awards verbiage for the Policies and Procedures Manual. The motion was SECONDED by Casey Jones. Motion CARRIED.

Secretary Meeting Minutes- The Board members were provided with a copy of the meeting minutes from the July 22, 2025, board meeting. A MOTION was made by Andrea Evans to approve the meeting minutes. The motion was SECONDED by Jackie McDonald. Motion CARRIED.

Status of Membership- Laurie Penterman reported that we currently have 327 members in the club, 263 being Open members, and 64 Youth members. Since our July meeting, the club has gained two new Open members and two new Youth members. No Open members or Youth members renewed their membership since the last meeting. Laurie continues to send out renewal notices to expiring members via email.

Financial Report- June Abbott reported that the balance in the checking account is \$2,959.99, there is \$32,238.20 in the money market account, and we have a balance of \$72.76 in the PayPal account, for a total cash balance of \$35,270.95. There is \$3,097.14 in the held funds, so there are \$32,173.81 available funds.

1. Can we move the Process Fiber class from the Garment category to the Wool category? They are the step from raw wool to skein. 2. Who is responsible for purchasing the WSG awards? There is \$350 in the budget for WSG Sweepstakes. Vanessa will purchase the awards

Old Business

2025 ARBA Convention

1. **Show Coop Donation Update-** The judging tables at the ARBA Convention are 8 ft. long. We're not exactly sure how many tables are used for Angora judging. KW Cages sells 4 compartment collapsible judging coops that are 40 X 20 X 14"H, (each compartment is 10 X 20") for \$157 each.) Jackie, Jen and Laurie will talk to Eric Stewart this weekend when they see him at Michigan Fiber Festival. Will they fit in the metal carts ARBA has?
2. **Banquet Update-** We do not have a Banquet Chairperson. Andrea looked into several restaurants in Indianapolis and it was decided to hold the Angora Banquet at The Rathskeller on Monday, November 17, at 6:00 pm. We will order off the menu with separate checks for each attendee. A deposit of \$15 per person is required to reserve your seat either mailed to June Abbott, or send via PayPal to narbc@yahoo.com.
3. **Booth Volunteers-** A sign-up of booth volunteers still needs to be completed. Jen will make a post about it on the NARBC Facebook page.
4. **Fund Raising for COD Holders-** We need to make sure there is no nepotism, and no emails will be sent to members. No membership lists will be used.
5. **Live Auctions-** Many breed clubs do live animal auctions at the ARBA Convention. Some do 50/50 with half of the money going to the person donating the animal and half going to the club, with some all funds go to the club. Members can see and feel the rabbits being auctioned 30 minutes before the auction begins. Perhaps if we held a live Angora rabbit auction, 50% of the proceeds could go to NARBC and the other 50% go towards Angora CODs. Beginning in 2026, COD animals need to be in 5 different barns, so we are encouraging people to have them. Andrea will look into guidelines and disclaimers, and see what ARBA Convention expectations are. Is an application needed? We may not be ready for this year.

New Business

Sweepstakes Chair- Graham Thomas does not wish to continue to be the Sweepstakes Chair. Jen is going to ask her sister, Allison Clark, if she wants to do it. Expectations are that the Sweepstakes be updated every other month. A schedule should be made for when it needs to be done.

Committees- The committees need to be revamped. If you are on the board, to need to be on at least one committee.

Commercial Fiber Policy- On July 22, Tammy Vaughn emailed the board the Commercial Fiber Policy Committee proposal that she and the members of the Commercial Fiber Committee came up with. It includes the purpose and responsibilities of the committee. A MOTION was made by Tammy Vaughn to accept the proposed NARBC Commercial Fiber Committee Policy. The motion was SECONDED by Lauren Cody. Motion CARRIED.

Online Auction Proposal- Tammy sent a proposal to hold an online auction showcasing Angora yarns, wool, and handcrafted Angora wearables. The proceeds from this auction would support NARBC and our efforts during the upcoming ARBA Convention being held in Indianapolis, Indiana from November 14-19, 2025. Bidding would open on October 18, at 11:45 PM EDT, and would close on November 18, at 8:00 PM EDT. Tammy needs people to help promote the auction, and she also needs \$130 reimbursement for "My Auction" fees. It could be run through the NARBC PayPal account. The \$130 is not in the budget, but it could get deducted from the profits made through the auction. A MOTION was made by Andrea Evans to accept the Online Auction Proposal. The motion was SECONDED by Lauren Cody. Motion CARRIED.

Chocolate Agouti Giant Angora COD- On July 7, 2025, Cory White was granted a Certificate of Development for the Chocolate Agouti Giant Angora. The first presentation of the Chocolate Agouti Giant Angora will be at the 2027 ARBA Convention.

Audit- A MOTION was made by Andrea Evans to have Lauren Cody and Deb Clemens to do an audit of NARBC's 2024-2025 financial records. The motion was SECONDED by Laurie Penterman. Motion CARRIED.

A MOTION to adjourn the meeting was made by Andrea Evans. The motion was SECONDED by June Abbott. The meeting was adjourned at 8:26 pm EST. Our next meeting will be held on Tuesday, September 16, 2025, at 7:00 pm EST via Microsoft Teams Meetings.

2. **Banquet Update-** So far 4 tickets have been sold.
3. **Booth Volunteers-** A sign-up of booth volunteers still needs to be completed. Jen will make a post about it on the NARBC Facebook page.
4. **Breed Chairs-** We are still in need of breed chairs for English Angoras and Giant Angoras. Lauren Cody said that her and Skyler Starrett will be the breed chairs for Giant Angoras. The breed secretaries write for the judge and then find a ramrod and runners. Jen will make a Facebook post asking for volunteers.
5. **Raffle Table-** Sheila George has volunteered to run the raffle table.
6. **Booth Decorating-** All of the winners from past ARBA Conventions and National Angora Shows have been found, but not all of their pictures have been found. If there is no picture, a picture of the breed of rabbit that won will be put up.
7. **Awards-** The Best Display awards are finished. The Variety awards are being made by Amy Netherton. The BOB and BOS awards are being made by a company that only takes credit cards. Laura Clark will put the cost on her credit card and get reimbursed. The awards need to be completed one month before Convention begins.

Certificate of Development-COD

1. Andrea Evans wrote some guidelines for promoting fund raisers to help COD holders with the many costs they have. These guidelines were emailed to all of the board members. Look them over, and we will discuss them at our October meeting.
2. Live Angora Rabbit Auction at the ARBA Convention- Andrea shared with the board the many things the National Mini Rex Club does in order to hold a live animal auction at the ARBA Convention. There is a committee of people that work together to make this happen. Last year the Mini Rex Club made over \$20,000 in the live animal auction. NARBC will not be holding a live animal auction at this year's ARBA Convention, but hopefully next year we can. Perhaps we could do a dry-run live animal auction at the 2026 National Angora Show in Reno.

New Business

Best in Show/Reserve in Show point Bonus- Should an Angora Specialty Show, which might have somewhere between 20-30 rabbits, have the same amount of points given for BIS and RIS as an All-Breed Show with over 500 entries? A MOTION was made by Laurie Penterman to have a cap of 300 points for BIS at an All-Breed Show depending on number of entries, and have the Angora Specialty Shows grant the BIS winners the number of points based on how many rabbits were entered. The motion was SECONDED by Tammy Vaughn. Motion CARRIED.

President's Award- Jen has chosen who will receive this award, and it will be presented at the Angora Banquet at the 2025 ARBA Convention.

Hall of Fame- There are two nominees for the 2025 Hall of Fame recipient. Jen will send the applications to the board, and we'll discuss this at our October meeting.

Board Meeting Minutes Continued

Constitution Bi-Laws: Article VII: Meetings Section 2 (Voting)- In the past board members were given a stipend to travel to the ARBA Convention because it was expected that they attend. Back then the board only met once a year at the ARBA Convention. Now the board meets monthly via the computer or phone, so it was decided that board members didn't have to attend the ARBA Convention, and the stipend was dismissed. The membership would need to vote to remove from the Constitution the words in Article VII: Meetings Section 2: "This meeting shall take place during the annual Convention of the American Rabbit Breeders Association." The board decided that it will hold a short meeting at Convention so we don't need to change the Constitution.

A MOTION to adjourn the meeting was made by Andrea Evans. The motion was SECONDED by June Abbott. The meeting was adjourned at 9:10 pm EST. Our next meeting will be held on Tuesday, October 28, 2025, at 7:00 pm EST via Microsoft Teams Meetings.

President Jen Richardson called the annual NARBC membership meeting to order on November 18, 2025, at 8:05 a.m. at the 102st ARBA Convention in Indianapolis, Indiana. The attendance sheet was circulated for members to sign in to show his/her attendance. There were 30 members in attendance.

10/9/2023 Annual Membership Meeting Minutes- Jen told the members that the minutes from the Annual Membership Meeting on October 28, 2024, were printed in the December 2024 edition of the Angora News. A MOTION was made by Colleen Boyd to approve the October 28, 2024, Annual Membership Meeting Minutes. The motion was SECONDED by Deb Roe. Motion CARRIED. Our Secretary Laurie Penterman, reported that NARBC currently has approximately 360 members in the Club. One positive note is that we have gained a good number of new Youth members in the past month.

Treasurer's Report- Our Treasurer June Abbott reported that at the present time there is \$1,950.63 in the checking account, \$32,350.39 in the money market account, and we have a balance of \$767.64 in the PayPal account, for a total cash balance of \$35,068.66. There is \$3,483.14 in the held funds, so there is \$31,585.52 total.

2025 ARBA Convention Angora Winners- All of the Open and Youth Angora Best of Breed and Best Opposite of Breed winners were announced, as well as the Best Display winners. Congratulations to all!

2026 National Angora Show and the 2026 ARBA Convention- Both shows will be held in Reno, Nevada. NARBC will be looking for volunteers to help at the ARBA Convention. A list of jobs will be put together. Breed Chairs will be needed, as well as a Breed Secretary.

2027 National Angora Show- 5 bids were received to host:

1. Bloomington, Illinois on April 17, 2027, in conjunction with the Illinois State Rabbit Breeders All-Breed Shows.
2. Wilmington, Ohio on April 17, 2027, in conjunction with the Diamond in the Hare RBA All-Breed Shows.
3. Greensboro, North Carolina on March 20, 2027 hosted by the East Coast Angora Specialty Club in conjunction with the North Carolina Rabbit Breeders Association All-Breed Shows.
4. Pendleton, South Carolina on April 17, 2027, in conjunction with the Flint Fire United Rabbit Rebels.
5. Lowell, Michigan on May 8, 2027, in conjunction with the Blood, Sweat and Tears Rabbit Club's All-Breed Shows.

The board discussed all of the different possibilities, and then we voted. The 2027 National Angora Show will be held in Lowell, Michigan on May 8, 2027, in conjunction with the Blood, Sweat and Tears Rabbit Club's All-Breed Shows. National Show bids will be due a little earlier next year.

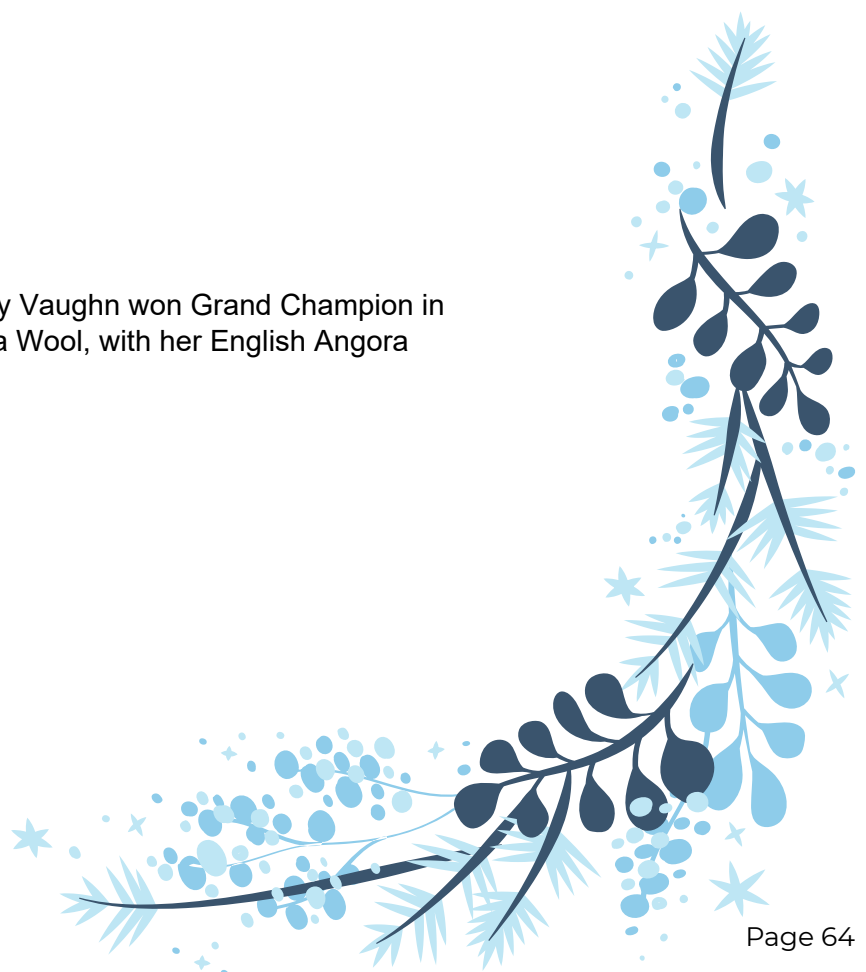

Hop Back In Angora History!

History and Genetics from the California Angora Guild Blog The Pointed White

Merry Christmas to you from Betty Chu and Casey Jones. We are going to share some information/discussion of the Pointed White history and characteristics.

In the early 1980s, Bill Sharp presented a "Himi" variety to the ARBA, and in 1984, this new sub-variety of English Angora was accepted by the ARBA. The marking of the "Himi" is the same as a Californian or a Himalayan; dark points and white body. Himi was accepted for showing in 1985, it was classified in the colored variety when showing in the regular classes but classified as white variety when showing in wool. Confusing? You bet. Show catalogs in 1985 had to give special instructions about how to enter "Himi". In 1986, when the new ARBA Standard of Perfection was published, "Himi" was renamed "Pointed White". For showing, it is in the white variety and remains the same since. I don't recall there was ever a presentation of Himi or Pointed White French Angora. It seems that when this sub-variety was accepted into English Angora, the French Angora did not have to go through a presentation. This happened before Satin Angora was accepted as a breed in 1987 and Giant Angora in 1988.



Hop Back In Angora History! – Continued

I acquired a "Himi" buck that I named "Jonathan". He was shown as a colored buck during his show days. It was actually much harder to compete in the colored buck class than in the white buck class as there were way more colored English Angoras shown than the REW. It was not uncommon in the 1980s to have over 20 in each of the colored classes while the white classes were usually in the single digits. Jonathan achieved Grand Champion status as a colored buck in 1985 and started his breeding career in 1986. The fun started, I learned a lot! Here is my first post about Pointed White on our blog [Northern California Angora Guild: Remember When: Pointed White English Angora, So Cute So Troubled](#)

In 2014 Casey and I were at a show where a judge made comments that she was an expert in color genetics and assured us that the tort was also temperature sensitive as the Pointed White because the tort had darker points than the body color thus similar to Pointed White. Not wanting to argue during the judging, we knew that was incorrect. The temperature sensitivity comes from the c(h) gene, not due to the "points". Tort has a full color C, the most dominant in the C series: C, c(chd), c(chl), c(h), c. The weakest of the colors is c that is the albino gene, while the himi gene c(h) is only one step higher than the albino. To further clarify the matter and to some degree to relief the frustration of hearing someone who was in a judge's position spreading erroneous information, I wrote another blogpost about the Pointed White: [Northern California Angora Guild: Temperature Sensitive Gene - Himi](#) The reason why the tort has darker points with lighter body color is due to the non-extension gene ee that limits the color to be extended to the rest of the body.

Pointed White is only accepted in non-agouti version. If one only breeds Pointed White to Pointed White, or Pointed White to a colored mate, it's not too hard to avoid the agouti pattern. If one is breeding a Pointed White to a REW, it may end up with some unexpected and undesirable results. The cc in REW can cover all the color genes, whether it's agouti or non-agouti. The offspring of a Pointed White and REW may result in offspring having agouti pattern in the ears or points. 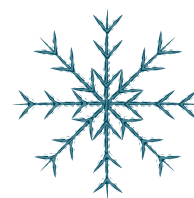
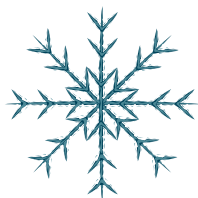

Judy Paris Remembered

It is reported on page 63 in the current November/December 2025 issue of the ARBA Domestic Rabbits magazine that Judy Paris has passed away. There was not a write-up about her, just a listing. Her passing makes me sad and not seeing anything written up about her makes me even feel worse. Judy was a notable English Angora breeder and exhibitor, and she was an excellent judge especially in judging wool breeds. I'd like to share some of my memories and the past from our Northern California Angora Guild blog.

I met Judy in 1986 when I went to my first out-of-state show and national level show. It was the 1986 Angora National held at Puyallup, WA. It was before the acceptance of Giant Angora and Satin Angora, so the National only had two breeds, the English Angora and the French Angora. There were a lot of breeders/exhibitors and numbers especially in the WA area. The blower had yet to be a grooming tool, each exhibitor would have small entries in shows as it was very difficult to keep many in coat. There were over 300 Angoras at that National, around 250 English and 100 plus French with close to a hundred exhibitors. Judy was one of the major person who worked to put on the show. We only met briefly in 1986, I accepted the trophy from her and Donna, the photo is included in the above link. When the ARBA convention came along in the fall, I heard that she won the English Angora BOB with a black senior doe at the 1986 convention at Columbus, OH. I had yet to go to any conventions, her winning made a big impression on me. Unfortunately I had not seen a photo of her winning rabbit so I could not include it in this memoriam.

Judy moved from WA to MO for love, then moved back to WA a few years later. When I saw her again, she had gotten her judge's license. From then on we saw her in our local shows often, see some of the show photos:

The thing I remember her the most was her free spirit and her sense of humor, she would say things that were unexpected but made sense. Here is a breeding advice she gave to us that most judges would not have done: During one show at Reno, Judy turned around and said to us, "Look at my butt, you want your Angora to have a round butt like mine." In the old days both English Angoras and French Angoras tend to have pinched hindquarters, thus this was a very useful advice. For many years after, when we were breeding and picking keepers, the common question was, "Are we getting a Judy Paris butt?"

Another interesting thing she did was when I discuss the perils of the wooden judging coops at the convention, she joined in to give her 2 cents worth from the point of view of an ex-English Angora breeder and a judge, she said "... the old coops suck..." how many judges are willing to say the equipment "suck" in writing? Creamy White Rabbit Chili

This has been a favorite of ours up here at different events during our long cold season. Sarah Vantrease started making it for some of our fiber and rabbit gatherings - it always goes super fast!

Great with some fresh baked bread or rolls!

- 1 pound boneless rabbit, cut int ½” cubes
- 1 medium onion, chopped
- 1-1/2 teaspoons garlic powder (or fresh chopped garlic, or jar garlic depending on your motivation)
- 2 15.5 oz cans Great Northern Beans, rinsed and drained
- 1 14.5 oz can chicken broth
- 2 4oz cans chopped green chilis (or 8oz+ of hatche chilis that have been fire roasted)
- 1 teaspoon salt
- 1 teaspoon ground cumin
- 1 teaspoon dried oregano
- ½ teaspoon pepper
- ¼ teaspoon cayenne pepper
- 1 cup sour cream
- ½ cup heavy whipping cream

In a large saucepan, saute rabbit, onion, and garlic powder in oil until rabbit is no longer pink. Add the beans, broth, chilis, and seasonings. Bring to a boil.

Reduce heat; simmer, uncovered for 30 minutes. Remove from heat. Stir in sour cream and cream. Serve immediately.

National Angora Rabbit Breeders Club,
Inc Constitution and By-Laws

PREFACE FOR THE CONSTITUTION:

Dr. Terry Reed, President of the American Rabbit Breeders Association, reminded the members of the National Angora Rabbit Breeders Club, Inc at the 59th Annual ARBA Convention in Seattle, Washington, that the ARBA is the parent organization for all of the specialty clubs and therefore we should be aware of the Constitution and By-Laws of the ARBA.

CONSTITUTION OF THE NATIONAL ANGORA RABBIT BREEDERS CLUB, INC

ARTICLE I: NAME

The name of this association shall be known as the National Angora Rabbit Breeders Club, Inc.

ARTICLE II: OBJECTIVE

The objective of this Association is to promote and improve the development of the Angora rabbit in all of its phases, to provide information, to advance and protect the interests of the public as well as those of the breeders, to encourage the breeding of the standard animals, to encourage and promote the formation of state, regional and local specialty clubs and provide necessary assistance.

ARTICLE III: AFFILIATION

This club shall be affiliated with the American Rabbit Breeders Association, Inc.

ARTICLE IV: MEMBERSHIP

SECTION 1: Eligibility. An owner or breeder of angora rabbits or a person interested in the promotion of the angora breed or the angora fiber may become a member of the Association upon payment of dues thereby agreeing to comply with all rules, regulations, and mandates of the Association.

SECTION 2: Classification. There shall be the following types of membership:

- A. Single Membership
 - 1. Individual adult members age 19 and over.
 - 2. Member is entitled to one (1) nontransferable vote in all matters pertaining to the Association.
- B. Youth Membership
 - 1. Members through the age of 18 years.
 - 2. Youth members may vote for Youth Director only.
 - 3. Youth members may not run for any office except Youth Director.
- C. Rabbitry Membership
 - 1. Consist of no more than two adult members who live at the same address.
 - 2. Each adult member is entitled to one (1) nontransferable vote in all matters
 - 3. pertaining to the Association.
Members must be named at the time of application.
- D. Family Membership
 - 1. Consists of two (2) adult members and all persons under the age of 19 who live
 - 2. at the same address.
 - 3. All members must be named at the time of application.
 - 4. Each adult member is entitled to one (1) nontransferable vote in all matters pertaining to the Association.
Youth Membership rules (set forth in Section 2, B. above) apply to all youth persons in a Family Membership
- E. Life Membership
 - 1. The Board of Directors may bestow Life Membership on any member of the Association for exemplary service, dedication, and/or outstanding contributions to NARBC, INC, provided the member has at least ten years membership in NARBC, INC.

2. Each Life Member shall be entitled to one (1) nontransferable vote in all matters pertaining to the Association.
 3. When a life membership is bestowed upon an individual, all future dues of the individual are waived
- F. Honorary Membership
1. The Board of Directors may bestow Honorary Membership on any person for outstanding contributions to the angora industry and/or NARBC, INC.
 2. The Honorary member's dues shall be waived.
 3. The Honorary Member shall have no voting rights or be able to hold office.
 4. The Honorary Member may choose to pay dues; and if he/she does pay dues he/she will have the rights associated with the membership type applied for.

SECTION 3: Privileges

- A. Each membership classification type (single, youth, rabbitry, family, life or honorary) will receive a subscription of the Association newsletter.
- B. Each individual member may compete for sweepstakes points.
- C. Each individual member may participate in the membership contest.
- D. A member in good standing shall be one whose dues are current in accordance with the provisions of these bylaws and who is not under disciplinary action.
- E. Voting rights, if any, depending upon your type of membership as stated in Article IV, Section 2.
- F. A member has the right to purchase a copy(s) of the Guide Book.

SECTION 4: Term and Renewal

- A. Membership shall begin on the date of the NARBC, Inc secretary's receipt. Membership dues shall expire on the last day of that month one year later (or multiple years later in the case of a multiple year membership or renewal).
- B. Renewal dues must be paid on or before the expiration date. Memberships not renewed within 30 days following the expiration date will result in loss of membership and sweepstakes points for the lapsed period.

SECTION 5: Dues and Fees

- A. The Board of Directors shall determine annual dues.
- B. All dues must be paid in U. S. funds.
- C. Dues are non-refundable

SECTION 6: Right to accept or reject membership

- A. The Board of Directors reserves the right to accept or reject, for cause, any application for membership or renewal.

SECTION 7: Authority

This Association shall have the authority to make such laws, establish such rules and adopt such regulations as may be necessary for the governing of its members.

ARTICLE V: OFFICERS

SECTION 1: The officers of the club shall be President, Vice-President, Secretary, Treasurer, four (4) Directors and one (1) Youth Director. All these officers are elected by the membership. The President, or in the absence of the President, the Vice-President with the approval of the Board of Directors, may appoint a person pro tempore. The Executive Officers shall consist of the President, Vice-President, Secretary and Treasurer. They shall be ex-officio members of the Board of Directors.

SECTION 2: The officers shall be elected by the membership by U.S. postage or bulk ballot.

SECTION 3: A member, to be eligible for any office, must have been a member of NARBC, Inc. for three (3) years immediately preceding applying for an office. be an owner/breeder of angora rabbits or have a strong interest in the promotion of the breeds, be over 18 years of age and a member in good standing,

except for the Youth Director, who shall be at least 12 years of age and under 19 years of age during the term of office. Membership dues shall be paid in advance through the full term of office being sought. ARBA membership is required.

SECTION 4: The term of office for all officers shall be four years. The President, Treasurer and two (2) Directors shall be elected in even years. The Vice-President, Secretary, and two (2) Directors and one (1) Youth Director shall be elected in the odd years.

SECTION 5: All Officers and Directors may serve consecutive terms in office as so elected by the membership.

SECTION 6: All officers shall assume office on August 1 and run through their term of office on July 31 of their respective year. Vacancies in any office shall be filled by appointment of the President, subject to a two-thirds (2/3) majority vote of the Board of Directors.

SECTION 7: Directors will be elected from four (4) Regions/Districts to facilitate the representation of all NARBC, Inc. members. In order to facilitate the representation of the youth members, there shall be one (1) youth director to sit on the Board of Directors. In the event that there is no candidate for director from within the district, and no one from the district willing to be appointed as director in case of a vacancy, the President may appoint another club member from outside the district as director pro tempore, subject to vote of approval by 2/3 majority of the Board of Directors. The four (4) Regions/Districts shall be designated as follows:

- 1: Maine, New Hampshire, Vermont, New York, Massachusetts, Connecticut, Rhode Island, Pennsylvania, New Jersey, Delaware, Ohio, Indiana, Illinois, Michigan. Canada: Nova Scotia, Prince Edward Island, New Foundland-Labrador, New Brunswick, Quebec, Ontario. International: Europe.
- 2: Maryland, Virginia, West Virginia, Washington, D.C., North & South Carolina, Georgia, Florida, Mississippi, Alabama, Kentucky, Tennessee, Puerto Rico. International: Caribbean, South America, Africa, Middle East.
- 3: Alaska, Washington, Oregon, Idaho, Montana, Wyoming, North & South Dakota, Nebraska, Iowa, Wisconsin, Minnesota. Canada: Alberta, British Columbia, Saskatchewan, Manitoba, Yukon, Northwest Territory, Nunavut.
- 4: California, Nevada, New Mexico, Arizona, Utah, Colorado, Texas, Louisiana, Arkansas, Kansas, Missouri, Oklahoma, Hawaii. International: Mexico, Central America, Pacific/Asia

ARTICLE VI: DISCIPLINE

SECTION 1: Any member wishing to file a complaint of misconduct against any other member of the NARBC, Inc shall cite the ARBA or NARBC, Inc Constitution and By-Laws and/or official ARBA show rules in their charge and submit those charges in writing along with a \$50.00 processing fee to either the NARBC, Inc President or Secretary, who shall promptly bring the matter to the attention of the entire Board of Directors.

SECTION 2: Any member against whom charges have been filed shall be furnished with a complete statement of the charges by the Secretary or President and shall be allowed 30 days to file a reply.

SECTION 3: The charges, together with the reply, if any has been received, shall be furnished each member of the Board of Directors for his consideration. The Board of Directors may, by two-thirds (2/3) majority votes, reprimand, suspend, or expel the member. Less than two-thirds (2/3) majority shall constitute acquittal of the charges

SECTION 4: Any member suspended or expelled shall not be eligible for reinstatement within one year of the date of suspension or expulsion and must be approved by the Board of Directors.

SECTION 5: If an Officer or Director does not fulfill his/her duties or shows a lack of interest in Club matters, he/she shall be asked to resign by the President or in the case of the President, by the Vice-

President, in the same manner as outlined in Sections 2 and 3. If he/she fails to do so, the Board of Directors, by majority vote, can declare the office vacant.

ARTICLE VII: MEETINGS

SECTION 1: The Annual Membership meeting shall be held during the annual Convention of the American Rabbit Breeders Association, Inc.

SECTION 2: The Board of Directors shall hold a meeting prior to the Annual Membership meeting. This meeting shall take place during the annual Convention of the American Rabbit Breeders Association, Inc. At the Board of Directors' meeting, four (4) of the Board members must be present to vote on any club business. Only Board members may cast a vote in any motion under consideration by the Board.

SECTION 3: At the Annual Membership meeting, twenty (20) members in good standing must be present to have a quorum. Quorum is defined as the number of members in good standing that must be present to make the annual meeting valid. A simple majority of the quorum at the Annual Membership meeting may approve necessary business matters and make decisions necessary to conducting Club business not otherwise handled by approved committees or the Board of Directors.

SECTION 4: The President may call additional meetings as deemed necessary to transact Club business or whenever requested in writing by at least two-thirds (2/3) of the Directors or by a simple majority of the membership in good standing. At such special meetings there shall be considered only the special business for which the meeting was called. Notice of such meetings (date and time) needs to be given to all Directors, 10 days in advance of meeting, unless it is an emergency.

SECTION 5: No vote by proxy will be allowed at any meeting of the club, either in the general meeting or in a meeting of the Board of Directors.

ARTICLE VIII: DISSOLUTION

In the event of a dissolution of this organization, all monies and assets held by the club at that time, shall be turned over to our parent organization, the American Rabbit Breeders Association (a nonprofit organization), to be used at their discretion for the Youth Scholarship Fund, the Research and Development Fund, or any such fund in existence at that time.

ARTICLE IX: AMENDMENTS

Any proposed Amendment to this document must be submitted in writing to the Constitution Committee for review to determine that it is correctly stated and is consistent with other provisions of the existing Constitution and By-Laws. The proposed change shall then be forwarded to the Board of Directors and the Newsletter Editor for inclusion in the next Newsletter. This Constitution may be amended by a two-thirds (2/3) majority of all votes cast by mail, provided all members in good standing are notified in writing of the proposed changes and furnished a ballot at least thirty (30) days before the closing of the polls; or may be amended at the annual meeting by two-thirds (2/3) majority of all good standing members present, provided there is a quorum (20 members) of the membership present.

BY-LAWS OF THE NATIONAL ANGORA RABBIT BREEDERS CLUB, INC

ARTICLE I: DUES: Deleted per vote 10/15/10

ARTICLE II: OFFICERS

SECTION 1: President

The President shall:

1. Preside over meetings.
2. Appoint all committees not provided for.
3. Call special meetings of the Club and Board of Directors.
4. Fill vacancies of office by appointment and all other duties of office.
5. The President shall be an ex-officio member of all committees and the Board of Directors.

SECTION 2: Vice-President

The Vice-President shall:

1. Perform all duties in absence of the President.
2. Automatically succeed to the office of President in the event of vacancy.
3. The Vice-President shall be an ex-officio member of the Board of Directors.

SECTION 3: Secretary

The Secretary shall:

1. Receive and act on all membership applications.
2. Maintain a complete set of books and records regarding memberships.
3. Publish a current membership list each year in the December deadline issue of the Angora News.
4. Shall maintain the Policies and Procedures Manual; and promptly update policy(s) upon a Board modification to a policy.
5. Forward all monies received on a monthly basis to the Treasurer.
6. Handle all correspondence and advise the President of any unusual matters.
7. The Secretary shall be an ex-officio member of the Board of Directors.
8. Prepare meeting minutes for all board meetings and send to the board members.
9. Prepare annual board meeting minutes.
10. Submit all approved board meeting minutes to the Newsletter Editor for Publication.
11. Submit annual meeting minutes to the Newsletter Editor for Publication.
12. Maintain and store all board meeting minutes.
13. Maintain and store all annual membership meeting minutes.
14. Review and edit the Angora News prior to publication.
15. The secretary is to send the email addresses to the publishing vendor of the newsletter for distribution via email.
16. Proof all ballot drafts received from the Elections/Voting Committee.
17. Send ballots to membership as determined by the Board.
18. Maintain and store club supplies, Guide Book, patches and banners.
19. Shall order, maintain, store and distribute ribbons for the rabbit wool judging and the wool/skein/garment competition.
20. Maintain and update Guide Book.
21. Complete and submit the charter renewal to ARBA in a prompt fashion.

SECTION 4: Treasurer

The Treasurer shall:

1. Be bonded to cover the assets of the Club (the bonding premium to be paid by the Club).

2. Maintain a bank account in the name of the Club and from it pay expenses which have been pre-authorized by either the Constitution and By-Laws or by a special vote of the, Board of Directors including amounts over budget items.
3. Maintain a complete set of financial books and records
4. Keep the financial books/records per the Records Retention policy.
5. IWill send a monthly report to the Board of Directors.
6. Will publish in each edition of the Angora News the financial status of the organization.
7. All financial reports and activities will be audited annually by the Audit Committee The audit shall be conducted at the close of each fiscal year.
8. The Treasurer shall be an ex-officio member of the Board of Directors.

SECTION 5: The Board of Directors

1. The Board of Directors is to include the four (4) regional and one (1) youth directors along with the President, Vice-President, Secretary and Treasurer.
2. The general supervision and conduct of the affairs of the Club shall be vested in the Board of Directors which shall have legislative powers.
3. The Board of Directors shall carry out instruction of Club-authorized expenditures, shall devise ways and all other duties that pertain to the office.
4. The Board of Directors will review annual financial statement and determine bond coverage previous to annual meeting.
5. Each Director shall act as an overseer to at least one committee and issue at least one committee report quarterly. Shall evaluate the progress of each committee under his/her direction and report to the President.
6. The Board of Directors may elect as honorary members any person distinguished for outstanding contributions to the rabbit industry. Honorary members shall have no right to vote or hold office.
7. The Board of Directors may, at their discretion, bestow life membership upon any member of the association who has distinguished himself/herself through exemplary service and dedication to the NARBC, Inc. Such a member must have had at least ten consecutive years membership in the association to qualify for this honor.
8. The Board of Directors as a body is solely responsible for making or changing policy within the club. No individual officer or director may make a policy change; it must be brought before the Board and approved by 2/3 majority vote of the Board. A policy is to be understood to mean an internal rule governing and guiding the ongoing operation of the club, as opposed to a one-time business decision made to facilitate the running of the club. No policy may be implemented which is not in accordance with the NARBC, Inc Constitution and By-Laws.
9. A simple majority vote of the Board of Directors is necessary to approve an action or decision unless elsewhere in this document specified to require a two-thirds (2/3) vote.
10. A Policies and Procedures Manual shall contain a record of all policies adopted by the Board of Directors and current procedures, with reference to the dates of their inception, and shall be consulted as necessary by the officers, directors and committee chairman, as well as be available to the membership when requested. Updates must be made in a timely manner.

ARTICLE III: FINANCES

SECTION 1: Compensation

Compensation for any NARBC, Inc position will be set forth in the Policies and Procedures Manual.

SECTION 2: Budget

- A. The Treasurer shall be Chair of the Budget Committee to propose an annual budget to the Board of Directors.
- B. The Board shall review the proposed budget and submit to the Newsletter Editor for publication in the March 1st deadline of the newsletter for the membership.
- C. The membership shall have 45 days from publication of the proposed budget to make comments, suggestions, and critiques of it to the Board for its consideration.

- D. The Board upon consideration of membership responses shall then by a majority vote approve any necessary amendments to the proposed budget and shall then adopt the budget by majority vote.
- E. Financial expenditures for special project(s) not included in the adopted budget must be approved by a majority vote of the Board of Directors.

SECTION 3: Audit

Every year the President shall appoint an Audit Committee (see Audit Committee under Standing Committees). This committee shall be selected from members in good standing of NARBC, Inc, consisting of no fewer than two members and not including either the President or Treasurer for the purpose of reviewing and auditing the financial records of the Association and reporting the results to the Board of Directors and membership at the ARBA Convention. The standards or methodology used in each review shall be determined by the committee undertaking the audit. The standards or methodology used shall be disclosed in the annual report of the committee to Board of Directors and the membership at the annual meeting of NARBC, Inc.

SECTION 4: Bond

- A. An Indemnity Bond or Crime Shield Policy shall be purchased by the Association.
- B. The Bond or Policy shall cover all members of this association who handle any Association funds.

SECTION 5: Fiscal Year:

The Association's fiscal year shall begin August 1st and end July 31st.

ARTICLE IV: PROCEDURE

SECTION 1: Robert's Rules of Order shall govern the parliamentary procedure of this Club.

SECTION 2: The order of business shall follow this order:

- 1. Call to order
- 2. Roll call of officers
- 3. Reading of the minutes
- 4. Report of officers
- 5. Report of committees
- 6. Unfinished business
- 7. New business
- 8. Discussion
- 9. Adjournment

ARTICLE V: COMMITTEES

SECTION 1: Standing Committees

- A. The Standing Committees of NARBC, Inc shall be, Audit; Boutique, Budget; By-Laws; Election/Voting; Fiber; Internet; Membership; Newsletter; Publicity; Show Advisory; Show Rules; Standards, Research and Development; and Youth.
- B. Chairperson and Members of the Standing Committees shall consist of active members of NARBC, Inc.
- C. All Standing Committees shall be an odd number of members, which includes the Chairperson, except the Audit Committee which may have any number.
- D. Committee Chairperson will:
 - 1. Be appointed at the Annual Membership Meeting by the President.
 - 2. Have their names, email and phone numbers listed in each newsletter.
 - 3. Receive comments and suggestions from the membership and the general public and reply to them when so directed by the Board of Directors.
 - 4. Provide progress reports at the meetings called by the President.
- E. Association members interested in serving on a Standing Committee shall submit their request, including reasons, in writing to the President.

- F. The President shall have the authority to make such replacements of Committee Chairperson and Committee Members as are considered to be in the best interest of the Association.

SECTION 2: Audit

- A. The committee shall review and audit the financial records of the Association and report the results to the Treasurer who will inform the Board of Directors.
- B. A copy of the Audit Report will be printed in the Angora News to inform the members of NARBC, Inc.
- C. An audit of the records of NARBC, Inc will be performed each year at the close of the fiscal year.
- D. This committee shall consist of no fewer than two members in good standing.
- E. The President and Treasurer shall not be members or Chairperson of this committee.

SECTION 3: Budget

The Budget Committee shall:

- A. Prepare the budget for the upcoming fiscal year.
- B. Submit a copy of the proposed budget to the Board of Directors prior to sending it to the Newsletter Editor for publication in the March deadline issue of the newsletter
- C. Contact the Elections/Voting Chairperson to include the budget ballot on the Elections ballot.
- D. The election ballot time guidelines shall be applicable to the budget ballot.

SECTION 4: By-Laws Committee.

The Bylaws Committee shall:

- A. Maintain continuous study of the By-Laws for the purpose of furnishing interpretations when requested by an officer or member of the Association and for the purpose of offering improvements or clarifications in the form of modifications.
- B. Offer amendments, if deemed desirable, for improvement or clarification in the prescribed manner for consideration at the annual meeting.
- C. Submit to the Board of Directors a current and correct copy of the proposed changes for approval prior to submission to the Newsletter Editor for printing in the newsletter.
- D. Upon adoption of an amendment or modification by the membership, they shall revise the necessary articles of sections to include the amendment, and shall furnish it to the Secretary of the Association within thirty (30) days following adoption.
- E. Submit to the Board of Directors a current and correct copy of the adopted amendments for approval prior to submission to the Newsletter Editor for printing in the newsletter.
- F. Furnish a current and correct copy of the By-Laws to the Newsletter Editor for inclusion in December deadline issue of the newsletter.

SECTION 5: Fiber Committee.

The Commercial Committee shall research and provide information on the commercial and business aspects of the Angora industry.

SECTION 6: Election/Voting Committee.

The Election/Voting Committee shall draw up election rules and publish them in the newsletter.

The Election/Voting Committee shall:

- A. Notify members of upcoming vacancies on the Board of Directors in the December 1st deadline issue of the newsletter.
- B. Receive nominations and/or resumes and verify the validity of each candidate's membership from the Secretary.
- C. Design a ballot and furnish a copy to the President and Secretary for approval prior to printing. Print the ballots in consultation with the President and Secretary as to the most cost-efficient method.
- D. Print the ballots in consultation with the President and Secretary as to the most cost-efficient method.
- E. Distribute the election ballots as determined by the Board by either USPS First Class, NARBC newsletter, Electronic or other means, to the General Membership by no later than May 15 of each year. Only members in good standing of NARBC as of April 1st as provided on a list by the Secretary shall receive a ballot.

- F. Accept only ballots postmarked by June 5th, unless falling on a Sunday, the following Monday, June 6th, shall be an official postmark; and the Board of Directors may authorize an extension of a balloting deadline in any vote as so needed.(10 October 2016)
- G. Notify the President and Secretary of any invalid ballots.
- H. Have the committee counts the votes and tabulate the results.
- I. Notify the President and Secretary of the election results.
- J. Notify candidates regarding the election results.
- K. Submit the election results to the Angora News for publication.
- L. The Election/Voting Committee shall also be responsible for additional ballot and voting responsibilities as directed by the President or Board of Directors.

SECTION 7: Social Media Committee.

The Social Media Committee shall organize and forward a list of updates and/or changes at the end of each month to the Webmaster. The NARBC, Inc website will be maintained by a private company/individual not associated with NARBC, Inc. The Association site shall, at a minimum, provides basic information concerning the Association and how to become a member. It may also include educational information and national show reports.

SECTION 8: Membership Committee.

The Membership Committee shall:

- A. Work with the Publicity Committee for the planning of, obtaining and revising an informational and membership brochure for distribution to potential members.
- B. Recruit new and renewal memberships.
- C. When notified, shall send get well cards or sympathy cards to member(s).

SECTION 9: Newsletter.

The Editor shall publish the Association's newsletter, *Angora News*, according to the following guidelines:

- A. There shall be published three issues of the *Angora News*, Association finances permitting.
- B. Deadline publications shall be: March 1st, August 1st and December 1st of each year.
- C. As a primary means of member-to-member communication, the newsletter will encourage and print articles submitted by members concerning any matters which may be of interest to the membership in the breeding or utilization of Angora rabbits or rabbits in general or of the Angora Rabbit Club or rabbit Associations in general.
- D. Initially the Editor may reject for publication any article, which seems to contain an attack on an individual of a personal nature rather than addressing a problem or matter in a manner befitting good taste. Copies of all such rejected material shall be provided to the Board of Directors shall make the final determination as to whether the article is printed.
- D. The newsletter Editor may be directed by the President or the Board of Directors to perform duties as assigned.
- E. The chairperson of the Newsletter Committee shall be designated Newsletter Editor.

SECTION 10: Publicity Committee.

The Publicity Committee shall:

- A. Provide information to the public and breeders as well as supply promotional articles to trade journals and various media.
- B. Provide an article to the ARBA publication.
- C. Plan, put into effect, and carry out a publicity program designed to secure new members and to encourage renewals.
- D. *Work with the Membership Committee to-* create, update, modify and print a pamphlet/brochure regarding NARBC, Inc.

SECTION 11: Show Advisory Committee.

The Show Advisory Committee shall

- A. Consist of the Vice President, the Secretary, and at least one (1) Adult Director.
- B. Advise clubs hosting the National Angora Show and those hosting Angoras at ARBA Conventions.

SECTION 12: Show Rules Committee.

The Show Rules Committee shall:

- A. Answer requests from the members for clarification of the present show rules.
- B. Revise show rules in accordance with the ARBA changes and settle problems that arise.
- C. Publish in the newsletter any amendment or modification of show rules.

SECTION 13: Standards, Research and Development Committee.

At least one officer or adult director shall serve on the Standards, Research and Development Committee.

The Standards, Research and Development Committee shall:

- A. Continually review the Standard of Perfection as set forth by ARBA.
- B. Handle all inquiries and concerns regarding the Standards.
- C. Receive and consider any proposed revisions requested by the membership or the ARBA Standards Committee for submission to the ARBA Standards Committee.
- D. Shall submit to ARBA Standards Committee, upon approval of the membership, requested revisions or modifications considered to be in the best interest of the breed.
- E. Shall be responsible for the research and development of the angora breeds. This shall include but is not limited to the establishment of new varieties/breeds and providing support to the members engaged in such development on behalf of the Association.

SECTION 14: Boutique Committee

The Boutique Committee shall:

- A. Maintain an inventory of items for sale.
- B. Reorder supplies as necessary, except the Guidebook,
- C. Determine the selling price of items.
- D. Place an ad in each issue of the Angora News regarding the items available for sale, including cost.
- E. Send the bills to the Treasurer for payment.
- F. Forward monies received to the Treasurer.
- G. Provide items for sale at the National Angora Rabbit Breeders Club, Inc Specialty Show and the American Rabbit Breeders Association Convention.

SECTION 15: Youth Committee.

The Youth Committee shall establish and maintain contact with youth groups throughout each area to form a network whereby youth may be encouraged and educated to the advantages of breeding and raising Angora rabbits. The Youth Director shall act as a co-Chairperson on this committee.

SECTION 16: Special Committees. The President or the Board of Directors may create special committees as necessary.

SECTION 17: Sanctions, Sweepstakes and Angora of the Year Committee.

The Sweepstakes, Sanctions and Angora of the Year Committee shall:

- 1. Shall issue sanctions to clubs.
- 2. Maintain an accurate record of all shows sanctioned by NARBC, Inc.
- 3. Forward a list of sanctioned shows to the Newsletter Editor for publication in each issue of the newsletter.
- 4. Forward all monies received to the Treasurer on a monthly basis.
- 5. Enforce the Show Rules of the Association to ensure prompt return of show reports.
- 6. Maintain a record of all show reports received from sanctioned shows.
- 7. Tabulate an accurate accounting of Sweepstakes points
- 8. Notify Show Secretaries having delinquent show reports at thirty (30) days and forty-five (45) days past their show date.

9. Submit a report of at least the top ten sweepstakes point earners in each breed, open and youth, with names and number of sweepstakes points included, to the Newsletter Editor for publication in each issue of the newsletter.
10. Forward to the Newsletter Editor a year-end report of the complete Sweepstakes standing for publication.
11. Forward an updated list of delinquent show reports to the Newsletter Editor for publication in each issue of the newsletter.
12. Order Sweepstakes awards for the membership.
13. Tabulate an accurate account of Angora of the Year in all four angora breeds in open and youth.
14. Forward to the Newsletter Editor a year-end report of the complete Angora of the Year standing for publication.
15. For each issue of the Angora News, submit a report of the top ten Angora of the Year point earners in each breed, open and youth with names the ear number of the angora to the Newsletter Editor.
16. Order Angora of the Year awards.
17. Distribute the Sweepstakes awards and Angora of the Year awards as determined by the Board.

ARTICLE VI: AMENDMENTS

Any proposed Amendment to this document must be submitted in writing to the Constitution Committee for review to determine that it is correctly stated and is consistent with other provisions of the existing Constitution and By-Laws. The proposed change shall then be forwarded to the Board of Directors and the Newsletter Editor for inclusion in the next Newsletter. These By-Laws may be amended by a two-thirds (2/3) majority of all votes cast by mail, provided all members in good standing are notified in writing of the proposed changes and furnished a ballot at least thirty (30) days before the closing of the polls; or may be amended at the annual meeting by two-thirds (2/3) majority of all good standing members present, provided there is a quorum (20 members) of the membership present.
